According to State Representative Zeb Zbranek, some of the new regulatory measures adopted by the Texas Natural Resource Conservation Commission to improve air quality in Southeast Texas are in conflict with state law. Mr. Zbranek has said that a law passed four years ago exempts Liberty and Chambers County residents from the strict tail pipe testing regulations included in the TNRCC's plan. Mr. Zbranek said yesterday that the Environmental Protection Agency has final approval of the plan and federal authority to override state law, the EPA will not accept the plan until it has been sent through the state legislature.

Liberty County Commissioners met yesterday and voted to table the public hearing set for January 9th on an ordinance restricting weight and use of commercial vehicles on county roads. Commissioners decided more information was needed and a workshop session on the matter is now scheduled for January 9th instead. Commissioners' Court also recognized two retiring officials. Precinct #1 Commissioner Harry Hylton attended his last meeting yesterday after 8 years of service and County Sheriff O.J. Stewart was recognized for his 12 years in office.

The Dayton City Council Monday night once again turned down a proposed final plat from JMC Homes for a new White Oak Ranch Development. The request from JMC's Jim Culberson was to develop a 30-acre large lot subdivision on FM 1008 directly across from the Oaks of Trinity Subdivision, which was approved over two years ago by the Liberty City Council. Council again raised objections of the aerated sewer systems proposed for each of the 25 lots. Council wants JMC to install a more traditional wastewater collection system in the subdivision.

With the possibility of severe winter weather ahead this week, Entergy's Sam Bethea said the electrical company is prepared for any major power problems in their service area here. While severe weather in Arkansas has left Entergy short-handed, Bethea said contract labor is available to deal with emergencies.

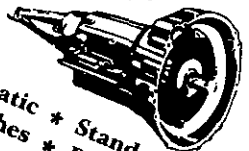
